1. Welcome, Prayer and Land Acknowledgment

3. Elections – Chair and Vice Chair

4. Schedule of Meetings and School Year Calendars

The 2023-2024 meeting schedule and school year calendars were shared with the committee members. The dates have been confirmed from September to December. Dates for 2024 to be shared with the members once the dates are finalized.

5. Update on the Summer School/Transition Program

We had another successful summer offering programs to our most at-risk students. The Summer Learning program took place at St. Jerome School in Kirkland Lake, supporting 17 kids from FDK to Grade 3; Pope Francis also offered a program for the same age group for 20 students. We did see a decline in participation over the 3 weeks in the group of older kids at Pope Francis.

We also offered the August Transition program at most elementary schools the week before school started. Nearly 100 students participated in this half day program over 4 days. Most students who participated had special education needs, but we also provided an opportunity to some of our new FDK students who we felt would benefit from the program. Our behaviour support team continues to be responsible for the planning of this program, with the support of the consultants we use from Sudbury.

6. Speech & Language Services

Therapy Path (John Stark) has been retained again this year to provide SLP services across the district. He now employs 4 therapy assistants who are in our schools daily providing therapy to students who require it. His staff is also in the process of completing the annual screen down with year 2 FDK students.

7. Specialized Classrooms – Update for 2023-2024

We have the same number of specialized classrooms as we did last year. We will spend some time this year reevaluating the use of the half time classrooms at both St. Patrick Schools. Depending on the needs of the students, they may better be served with a different model.

8. IPRCs and IEPs Fall 2023

Schools are just tying up the fall round of IPRCs. IEPs are due to go home on the 12th.

9. Agency Reports

Cochrane Temiskaming Resource Centre

The agency will be launching a virtual referral system with October as the estimated release time. The agency would also, like to offer a presentation to school staff members to show some of the services available through the CTRC.

Daphne advised she would support the presentation and offer it to Resources Teachers and Board Leads. The presentation would be well received by all those in attendance.
